The attached B.C. Reg. 562/75 appeared in the B.C. Gazette dated September 2, 1975 (received September 17). The amendments are those which were drafted at the same time as the amendments to the Act were drafted.

This single page is issued with the intention that you amend your own Strata Title Regulations now appearing in the General Survey Instructions. No reprinting and consolidation of the present B.C. Reg. 534/74 will be done at this time.

The amendments prepared by the Committee of our Corporation were received by the Department of Housing who now administer the Act (in place of the Attorney-General's Department who were formerly in charge), too late to be included in the latest amendment.

That Department has been requested to consider the committee recommendations as a further amendment, at an early date.

STRATA TITLES ACT

ORDER IN COUNCIL 2743, APPROVED AND ORDERED AUGUST 21, 1975

Pursuant to the Strata Titles Act, and upon the recommendation of the undersigned, the Administrator, by and with the advice and consent of the Executive Council, orders that the Strata Titles Act Regulations, made by Order in Council No. 2578 and being B.C. Reg. No. 534/74 be amended as follows:

- 1. Section 10 is amended
 - (a) by adding "or consolidation" after "resubdivision",
 - (b) by striking out "31 (2)" and substituting "31 (3)".
- 2. Section 14 is repealed.
- 3. Section 21 is amended by striking out "4 (1)" and substituting "4 (2)".
- 4. The following sections are added after section 23:
- 24. Notification of change of unit entitlement and of adopting a schedule of value upon destruction pursuant to section 66 (2) (d) of the Act shall be in Form 12 of these regulations.
- 25. The new development certificate required by section 4 (1) of the Act shall be in Form 13 of these regulations.
