## LAND ACT FEES REGULATION

### Fees

1. A person applying under the Land Act shall pay to the Minister of Finance and Corporate Relations for a matter itemized in Column 1 of the Schedule the fee set opposite that item in Column 2 of the Schedule.

### SCHEDULE

1.	For an application for a Crown grant, lease, licence of occupation, permit, easement or right of way	\$100.00
2.	For an application for the establishment of a public road allowance under section 75 of the <u>Land Act</u>	\$250.00
3.	For an application for a declaration of intention under section 55 of the <u>Land Act</u> for inclusion of a waterbody or road in a Crown grant subdivision	\$500.00
4.	For issuance of a lease or of a licence of occupation	\$150.00
5.	For issuance of a permit	\$ 50.00
6.	For issuance of a Crown grant	\$150.00
7.	For issuance of an easement or statutory right of way where the easement or statutory right of way is shorter than 25 km	\$150.00
8.	For issuance of an easement or statutory right of way where the easement or statutory right of way is 25 km or longer	\$500.00
9.	For noting the cancellation of a mortgage of a disposition	\$ 50.00
10.	For application for a replacement of a disposition	\$ 50.00

| 14. | For the preparation of an uncertified copy of any document that has been issued pursuant to a disposition   | \$ 15.00             |
| 15. | For the preparation of a certified true copy of any document that has been issued pursuant to a disposition   | \$ 50.00             |
| 16. | For the extracting of information from Ministry records   | \$ 50.00<br>per hour |
| 17. | For the issuance of survey instructions and the final plan examinations for surveys of Crown land, including easements or statutory rights of way less than 25 km in length   | \$300.00             |
| 18. | For the issuance of survey instructions and the final examination of survey plans of easements or statutory rights of way which are 25 km or longer   | \$ 50.00<br>per hour |
| 19. | For reinspection of a disposition   | \$100.00             |
| 20. | For reinstatement of a cancelled disposition  | \$300.00             |
