OFFICIAL SURVEYS ACT

ORDER IN COUNCIL No. 2071, APPROVED JUNE 29, 1967, CONSTITUTING
INTEGRATED SURVEY AREA No. 1

That under the *Official Surveys Act Amendment Act, 1964*, being chapter 35, Statutes of British Columbia, 1964, which Act came into force and effect by Proclamation of the Lieutenant-Governor on the 1st day of August, 1966, the Lieutenant-Governor in Council may, from time to time, by regulation constitute any portion of the Province an integrated survey area and define the boundaries thereof in the regulation:

That under authority of the aforementioned Act the Surveyor-General has made regulations governing the conduct of surveys in an integrated survey area, which regulations were published in Part II of the British Columbia Gazette of April 13, 1967, as B.C. Reg. 84/67:

That a sufficient number of co-ordinate control monuments have been established in the north-westerly portion of The Corporation of the District of Surrey to enable the constitution of this area as an integrated survey area:



That it is in the public interest to require that all surveys, situated within the area referred to in the preceding paragraph, which are commenced after the publication of the regulation based on this Order shall conform to the aforementioned Act and regulations:

And that, under authority of the *Official Surveys Act Amendment Act, 1964*, being chapter 35 of the Statutes of British Columbia, 1964, the area defined in Schedule A hereunto attached be constituted by regulation to be published in the British Columbia Gazette as Integrated Survey Area No. 1.

SCHEDULE A.—INTEGRATED SURVEY AREA No. 1

All that parcel or tract of land situated in Group 2, New Westminster Land District, comprising a portion of The Corporation of the District of Surrey and more particularly described as follows: Commencing at Co-ordinate Control Monument 5364, being located at the intersection of 96th Avenue and River Road; thence in a general north-easterly direction in a series of straight lines connecting, in sequence, Co-ordinate Control Monuments 5365, 5367, 5366, 5368, 5369 to Monument 2802; thence northerly in a straight line to the intersection of the centre line of 120th Street with the westerly production of the centre line of 102nd Avenue; thence northerly along the said centre line of 120th Street and its northerly production to an intersection with the centre line of Scott Road; thence north-easterly along said centre line of Scott Road and its north-easterly production to an intersection with the centre line of 124th Street; thence northerly in a straight line to Co-ordinate Control Monument 5796; thence easterly in a straight line to Co-ordinate Control Monument 5347 and continuing easterly in a straight line to Co-ordinate Control Monument 5346; thence northerly in a straight line to Co-ordinate Control Monument 5345 and continuing northerly in a straight line to Co-ordinate Control Monument 5787; thence easterly in a series of straight lines connecting, in sequence, Co-ordinate Control Monuments 5405, 5780, 5401, 5400 to Monument 5390; thence northerly in a straight line to the intersection of the centre line of 136th Street with the westerly production of the southerly limit of 114th Avenue; thence easterly along said westerly production and continuing easterly along the said southerly limit of 114th Avenue to an intersection with the centre line of 140th Street; thence northerly along the said centre line of 140th Street to an intersection with the centre line of 116th Avenue; thence northerly in a straight line to the intersection of the southerly production of the centre line of 140th Street with the centre line of King Road; thence northerly following the said southerly production of 140th Street, the centre line of 140th Street and the northerly production of said centre line to an intersection with the centre line of 117A Avenue; thence easterly in a straight line to Co-ordinate Control Monument 5413; thence easterly in a straight line to the intersection of the northerly production of the centre line of 148th Street with the centre line of 117A Avenue; thence easterly along the said centre line of 117A Avenue to its intersection with the westerly limit of the Trans-Canada Highway as said highway is shown on Registered Plan 21734 on file in the Land Registry Office, New Westminster; thence south-easterly along the westerly and south-westerly limit of the Trans-Canada Highway as said highway is shown on Registered Plans 21734 and 28411 on file in the Land Registry Office, New Westminster, to an intersection with the centre line of 152nd Street; thence southerly in a series of straight lines connecting, in sequence, Co-ordinate Control Monuments 5199, 5537 to Monument 5066; thence westerly in a series of straight lines connecting, in sequence, Co-ordinate Control Monument 5288 to Monument 5289; thence northerly in a straight line to Co-ordinate Control Monument 5535; thence westerly in a straight line to Co-ordinate Control Monument 5524; thence due south to a point on the easterly production of the southerly limit of 100th Avenue; thence westerly along said easterly production and continuing westerly along said southerly limit of 100th Avenue to a point on the straight line between Co-ordinate Control Monuments 5214 and 5215; thence southerly in a straight line to Co-ordinate Control Monument 5215; thence southerly in a straight line to Co-ordinate Control Monument 5216; thence westerly in a series of straight lines connecting, in sequence, Co-ordinate Control Monuments 5290, 5546, 5291, 5147, 5292, 5055, 5293, 5294, 5507, 5295, 5296, 5297, 5298, 5299, 5300 to Monument 5364, being the point of commencement.
