OFFICIAL SURVEYS ACT

REGULATION MADE BY ORDER IN COUNCIL 2123, APPROVED JUNE 2, 1972, PURSUANT TO SECTION 13, CONSTITUTING INTEGRATED SURVEY AREA 9

Integrated Survey Area 9-All that part of The Corporation of the City of Cranbrook as shown outlined on the plan and more particularly described as: Commencing at the intersection of the centre line of Van Horne Street South and the centre line of Third Avenue South; thence northeasterly along the centre line of said Van Horne Street South and the centre line of Van Horne Street North to its intersection with the centre line of Fourth Street North; thence southeasterly along the centre line of Fourth Street North to its intersection with the centre line of Kootenay Street; thence northeasterly along the centre line of Kootenay Street to its intersection with the centre line of 10th Street North; thence easterly along the centre line of 10th Street North to its intersection with the centre line of 20th Avenue North; thence southerly along the centre line of 20th Avenue North to its intersection with the centre line of Second Street North; thence easterly along the centre line of Second Street North to its intersection with the centre line of 24th Avenue South; thence southerly along the centre line of 24th Avenue South to its intersection with the centre line of Second Street South; thence easterly along the centre line of Second Street South to its intersection with the centre line of McKenzie Drive; thence southerly along the centre line of McKenzie Drive to its intersection in Seventh Street South with the production easterly of the southerly boundary of The Corporation of the City of Cranbrook, as described in page 435 of The British Columbia Gazette, Part I, dated February 11, 1971; thence westerly along the easterly production of the said southerly boundary of The Corporation of the City of Cranbrook and continuing in a general westerly and southerly direction following the boundary of The Corporation of the City of Cranbrook to its intersection with the centre line of Fourth Avenue South; thence continuing westerly in a straight line to an intersection with the centre line of Third Avenue South; thence northerly along the centre line of said Third Avenue South to its intersection with the centre line of Van Horne Street South, being the point of commencement.
