CIRCULAR LETTER TO ALL BRITISH COLUMBIA LAND SURVEYORS

Re: Rights of Way Crossing Forest Roads

Notwithstanding the provisions of Section 164 of the General Survey Instructions, surveys of rights of way over Crown lands which cross surveyed or unsurveyed Forest Roads should include the Forest Roads within the right of way under survey.

Intersections with the boundaries of surveyed Forest Roads shall be tied and posted in the usual manner, however, the boundaries of the Forest Road within the right of way under survey shall be depicted by broken black lines.

Unsurveyed Forest Roads shall be labelled as such and depicted on the plan by broken black lines.

The areas of Forest Roads within the right of way under survey shall not be deducted from the total area of the right of way.
