LTSA Bylaws and Operating Agreement

In 2020/21, the Board undertook the following Bylaw amendments:

- Destruction of Records –

 Owner Transparency Act"
- Skills and Experience Profile authorized amendments to Schedule A to be in effect April 1, 2021
- Board Compensation and Expensesauthorized amendments to Part
 5 (Directors' Remuneration and Reimbursement) to reflect:
 - expanded amounts for individual Director education/development in effect June 18, 2020
 - a 1% increase to all Director compensation amounts to be in effect April 1, 2021
 - housekeeping amendments to streamline the approval process for non-substantial education expenses to be in effect April 1, 2021.

- LTSA Fees authorized amendments to Part 13 (Service Fees) to reflect:
 - CPI fee increase of 2% which came into effect April 1, 2020
 - new fee under the Land Owner Transparency Act to be in effect November 30, 2020 [[AF/BD]

New Directors appointed April 1, 2020 were provided with dedicated orientation sessions which were delivered in a phased-approach over the course of the fiscal year.

LTSA Fees

For the 2020/21 reporting period, and under the authority of the Land Title and Survey Authority Act, the LTSA Board authorized the following in respect of fees:

- Bylaw amendment to apply a CPI increase of 2% for fees established by LTSA under the Land Act, the Land Title Act, the Mineral Tenure Act, the Oil and Gas Activities Act General Regulation and LTSA Administrative Fees which came into effect at the start of this fiscal year on April 1, 2020.
- New fee for a service under the Land Owner Transparency Act.

Board Compensation

The Board Chair, Committee Chairs and Board Directors are compensated for their time by way of annual honorariums. For the period April 1, 2020 to March 31, 2021, annual honorariums for Board Directors were as follows:

- Board Chair: \$67,620 per annum
- Committee Chair: \$23,788 per annum
- Board Director: \$14,235 per annum

Other than the Board Chair, the Directors are additionally entitled to daily meeting fees; during 2020/21 the rate for a full-day meeting was \$836/day. For the 2020/21 fiscal year, there are approximately twenty-six Board and Committee meeting days, and seven CEO Search Task Group meeting days.
