

CIRCULAR LETTER NO. 488

December 21, 2022

TO ALL BRITISH COLUMBIA LAND SURVEYORS

Re: Integrated Survey Area Annulments and Redefinition

The Surveyor General, under the authority of Section 12(1)(c) of the *Land Survey Act* has ordered¹ the annulment of the following Integrated Survey Areas (ISAs):

- ISA No. 7, District of Logan Lake;
- ISA No. 11, City of Duncan; and
- ISA No. 27, City of Rossland.

As a result of these annulments, legal surveys within these former ISAs are no longer required to be integrated according to Part 2-3 of the Survey and Plan Rules.

The coordinate control monument listings for these former ISAs have also been removed from the Surveyor General section of the LTSA website under the [Integrated Survey Area Program](#).²

The annulment of these ISAs is a result of a comprehensive review of the ISA Program that involved consultation with all 52 municipalities with ISAs in their vicinity, as well as a focus group of land surveyors who regularly practice within ISAs, and GeoBC.

The annulment of ISAs No. 7, 11, and 27 are effective as of December 21, 2022.

As part of the comprehensive review process it has been determined that the ISA boundary for ISA No. 32, City of Parksville needs to be modified to better fit around the existing undisturbed coordinate control monuments. As such, under the authority of section 12(1)(b) of the *Land Survey Act*, the Surveyor General has ordered³ the boundaries of ISA No. 32 redefined effective December 21, 2022.

The official definition of the boundary of ISA No. 32 has been updated, and as per [Circular Letter 486](#),⁴ the definition of all ISAs continues to be the ISA boundary as displayed in "ParcelMap BC Search for Land Surveyors," viewable through myLTSA.

The digital definition of all ISA boundaries continues to be available for download from the [Geographic Data Warehouse⁵](#) maintained by Data BC should you wish to add it to your own mapping applications.

The coordinate control listing for ISA No. 32 has also been updated under the authority of section 13(6) of the *Land Survey Act*. This update accounts for the change in the ISA boundary and includes all points within the updated ISA boundary. No change has been made to the horizontal or vertical coordinate values for any point in the listing. The official PDF listing is available on the LTSA website under **Professionals→ Surveyor General→ Integrated Survey Area Program** and then by clicking on the ISA number.
